ePortal – User Guide – Account Creation & Login

- I. General Information
 - A. Case Types Available to be accessed via eCourt.
 - 1. The Spokane Municipal Court employs three separate electronic case management systems.
 - a. The eCourt system for managing the following case types:
 - i. All simple misdemeanor and gross misdemeanor criminal offenses.
 - ii. Civil infractions for traffic, non-traffic, and code violations.
 - iii. Civil matters related to the towing and/or impound of vehicles on public property.
 - iv. Civil matters related to removal, adoption, and euthanasia of animals by animal control enforcement authorities.
 - B. Case Types Unavailable to be accessed via eCourt
 - 1. The <u>Aims Parking System</u> manages all parking infraction matters.
 - 2. Verra Mobility Safety Enforcement System manages all photo-enforcement infraction matters.
 - C. Hyperlinks in User Guides
 - 1. To make the experience more user friendly, all Spokane Municipal Court user guides make extensive use of hyperlinks.
 - a. Hyperlinks are a reference (electronic link) to data, documents, webpages, etc., that the user can follow by clicking or tapping.
 - 2. Hyperlinks are indicted by blue underlined text like this: Aims Parking System
 - 3. Selecting/clicking on the hyperlink will take you directly to the referenced data, documents, or webpages.
 - a. Depending on the security settings in your computer's web browser, you may receive a popup message requiring your permission to be redirected to the location of data, document, webpage, etc., represented by the hyperlink.
- II. Creating an eCourt Portal Account
 - A. Spokane Municipal Court Website (Skip this step if you have an existing portal account)
 - 1. Proceed to the <u>Court website</u> and compete
 - a. Attorneys & legal support staff: <u>Request for eCourt Portal Login Permissions Attorneys & Staff</u>
 - b. Defendants/ Other Filers: : <u>Request for eCourt Portal Login Permissions Defendants &</u> <u>Other Filers</u>
 - c. Complete all appropriate form fields and click the "Submit" button two thirds of the way down the page on the right.
 - 2. Separate login requests are required for each attorney and staff member in a firm.
 - a. The loaning of Spokane Municipal Court login credentials is *strictly* prohibited.
 - B. Process Following a Request for Access
 - 1. The Court will administratively review your request for login permissions.
 - a. If your request is approved:
 - i. You will receive a no reply email from noreply_ecourt_portal@spokanecity.org with the title, "eCourt Portal Access Approved".

- ii. Follow the one-time link provided in the email, log into the portal, and change your temporary password to a permanent password of your choice that complies with the system's password security requirements.
- b. If your request is not approved, you will receive a written communication from the Court notifying you of the disapproval and the basis for the action.
- III. Accessing the ePortal.
 - A. eCourt Portal Login Procedure.
 - 1. The eCourt Portal is located at: <u>https://ecourt.spokanecity.org/publicportal/.</u>



2. Once at the eCourt portal home screen, select/click the "Login" button on the right side of the blue banner under the Municipal Court Seal.

- 3. On the account login screen:
 - a. Enter the email you used to obtain your login credentials in the "E-mail" field.
 - b. Enter your password in the "Password" field.
 - c. Select/click the "Login" button beneath the password field.
